Please note that an individual is entitled to one delegate card only, and cannot therefore represent more than one affiliated organisation, or attend the meeting in more than one capacity.

For those entitled to attend either as a member of the Management Board, as a Past President or Life Member of the Swim England West Midland Region or relevant ASA District, or those identified as standing committee secretaries, an individual form is attached to this email. In the case of error, please contact the Regional Office without delay.

A member of the Council or a club, body, association or organisation affiliated to the Region that wishes to question or have discussed any item in the Annual Report or the Financial Statements shall indicate their intention by giving notice to the Regional Office no later than seven days prior to the Annual General Meeting.
